



GENERAL TERMS AND CONDITIONS

Noughty 90's Festival

1. GENERAL TERMS AND CONDITIONS

- a) These Terms and conditions (T&Cs) incorporate, and should be read together with, any Vendor's and/or Agent's T&Cs or regulations, which you can obtain from the point of purchase from the Official Agent
- b) Artists and billed attractions may be subject to change
- c) No trading or promotional activities are allowed within the venue without Noughty 90's Festival prior consent.
- d) Goods using unauthorised event logos and unauthorised professional recording equipment must be surrendered to staff.
- e) Photographic equipment is permitted provided that it is for personal non-commercial use only. In the event of any subsequent commercial use, the bearer agrees to pay the Promoter for the cost of a licence issued by the Promoter for permission to take photographs / visual / audio recordings for commercial use.
- f) Do not buy tickets or goods from unlawful street traders/touts. They are invalid.
- g) You give your express consent to your actual/ simulated likeness to be included for no fee within any audio or visual recording to be used in any media for any purpose at any time. This includes filming by the police or security staff which may be carried out for the security of customers and/or the prevention of crime.
- h) No unauthorised vehicles will be allowed on site.

2 APPLICABILITY OF THE GENERAL TERMS AND CONDITIONS

- a) These General Terms and Conditions apply to all offers, orders, legal relationships and contracts pursuant to which Noughty 90's Festival provides products or services of any nature whatsoever to the Customer, also if these products or services are not described or not further described in these General Terms and Conditions.
- b) Noughty 90's Festival expressly rejects other conditions of the Customer.
- c) The parties may only agree changes in relation to the General Terms and Conditions in writing. Noughty 90's Festival is entitled to change the General Terms and Conditions and declare changed general terms and conditions applicable to Contracts. Changed general terms and conditions shall be published on Noughty 90's Festival's website for consultation.

3. AGE POLICY

- a) All attendees must be aged 18 years or older.
- b) We do not accept any parental or supervisory duty of care or liability for any under 18's on site.

c) All attendees must have valid and in-date government issued photographic ID. These include drivers licenses, provisional licenses, passports, and cards bearing the PASS hologram such as citizenship cards.

4. TICKETS AND WRISTBANDS

a) Tickets are non-transferable and non-refundable and only valid when purchased from official agents of Noughty 90's Festival.

b) Tickets/wristbands purchased from unauthorised sources will be rendered invalid and refused admission.

c) Tickets must be exchanged for a wristband on first entry at a wristband exchange.

d) Tickets must be valid, presented in full, with stubs and not tampered with (in the event of accidental damage, refer to point of purchase prior to event). Tickets remain the property of Noughty 90's Festival.

e) E-Tickets will be accepted.

e) Noughty 90's Festival will not issue duplicates for lost or stolen tickets or wristbands.

f) Tickets cannot be used as part of any marketing, media or sales promotion, without the prior written consent of Noughty 90's Festival.

g) The ticket holder is responsible for their tickets until it is exchanged for a wristband and then responsible for their wristband for the duration of the event.

h) All wristbands remain the property of Noughty 90's Festival.

i) Tickets, unless an otherwise specified Group Ticket entitles one person access to the Noughty 90's Festival, Brighton.

j) Tickets purchased entitle the holder to access only and the Ticket Holder understands that all other services within the site are subject to in site purchases.

k) The Ticket Holder undertakes to observe and uphold all the terms, conditions, additional directives and statements of the Noughty 90's Festival at all times.

l) The Tickets distributed by Partners of Noughty 90's Festival or Noughty 90's Festival themselves remain the property of the Event Holder at all times.

m) Following receipt, the Customer must check the Tickets, since errors cannot always be corrected.

n) If a Ticket of the Customer is damaged to the extent that its authenticity can no longer be verified, the Customer must contact Noughty 90's Festival as soon as possible.

o) Special requirements, such as reserving places for wheelchair users, must be clearly communicated in good time. Noughty 90's Festival cannot give any guarantee whatsoever that special requirements can be met.

- p) Gates will open at 12pm on Saturday 18th July 2020
- q) The Event will run from 12:00 - 22:00
- r) Noughty 90's Festival reserve the right to alter time slots of the event.
- s) Last entry to the Festival is 5pm. There is no readmission. Once ticket holders have exchanged their ticket for a wristband, they cannot leave the site and re-enter.
- t) If you arrive after last entry you will be denied entry.
- u) No refunds will be processed for late arrivals.

5. REFUNDS/CANCELLATION

- a) Tickets are NON-Refundable, NON-Transferable and only considered on major cancellation, substantial alteration or by special exception. The circumstances are to be determined entirely by Noughty 90's Festival.
- b) Noughty 90's Festival shall not be liable for any losses, costs, damages, or expenses suffered or incurred as a direct or indirect result of event cancellation beyond our control however, to include without limitation, any act of God, communicable disease, pandemic or epidemic.

6. SECURITY

- a) Noughty 90's Festival reserves the right to evict a customer without refund, and/or refuse admission.
- b) You may be body/bag searched at the entrances, on the site or when leaving.
- c) Any item(s), reasonably considered for use as a weapon, which may cause danger, offence or disruption to any other person, must be surrendered to staff.
- d) Any person carrying illegal items or carrying out illegal activity will be given to the Police and refused entry.
- e) Anti-social behaviour may lead to eviction

7. DAMAGES/LOSSES

Noughty 90's Festival is unable to accept any liability for personal or property damages, losses (including surrendered items).

8. BANNED ITEMS

- a) Banned from event - Aerosols over 250ml, airhorns, glass, illegal substances, drugs, 'legal highs' – this includes Nitrous Oxide and associated equipment including balloons, unidentified substances, new psychoactive substances (NPS), illegal items, laser equipment/pens, megaphones etc.

- b) Ticket Holders may not bring – Bags larger than A4 in size, cans, alcohol of any kind, audio recorders, Food or Drink of any kind.
- c) Free, unlimited, clean drinking water will be available from water stations inside the festival.
- d) If you need to bring specific food or drink or medication due to a pre-existing medical condition, please bring supporting medical evidence.
- e) Anyone resisting the surrender of disallowed items or disregarding these conditions will face eviction.
- e) Items that are surrendered or confiscated will not be returned.

9. FIRE AND SAFETY

- a) Fires are not permitted in the arena.
- b) Smoking is not permitted in enclosed public spaces or buildings including Arena big tops. This includes e cigs/vaping.
- c) Excessive exposure to loud music may cause damage to your hearing.
- d) Pyrotechnics, lasers, smoke machines, strobe lighting/special effects may take place during some performances.
- e) The use of Drones or similar equipment for any reason is prohibited on or near the event without written permission from Naughty 90's Festival.
